ALL SUBJECTS INVOLVED IN INMATE'S ESCAPE ARE IN CUSTODY

Yesterday morning at approximately 4:30 AM hours, Charles J. Conrad III, escaped from the Nelson Coleman Correctional Center. Conrad, who is currently an inmate at the Corrections Facility was working in the kitchen when he escaped by climbing a fence near the facility's dumpster.

At approximately 2:15 PM yesterday afternoon Deputies and Detectives with The St. Charles Parish Sheriff's Office located inmate Charles Conrad at a Kenner Hotel. Due to the hotel being located in Kenner, Louisiana, St. Charles Sheriff's Office contacted Kenner Police Department before apprehension was made by St. Charles. Conrad was booked in Kenner as a Fugitive from St. Charles Parish then transported back to St. Charles Parish Sheriff's Office.

Erica Williams was arrested for picking up Conrad and assisting with the planning of the escape. Wendell Conrad was arrested for also picking up Conrad and renting the Kenner Hotel room.

Ayo, who is an inmate at the Nelson Coleman Correctional Center was rebooked for Assisting Escape. Ayo made it possible for Conrad to escape by hiding him on a cart covered with garbage and empty boxes. Ayo then pushed Conrad on the cart outside the facility to the dumpster area.
