Sheriff Greg Champagne reports that Arrestees' #1 & #2 were arrested after breaking into the residence of a 31 year-old female. The female was home with her 10 year-old daughter at the time of the incident. Officers arrived on the scene while both subjects were still inside the residence. Both subjects were apprehended, arrested, and booked accordingly. As of press time today, bonds have not been set. This incident is believed to be drug related. Following the incident both of the homeowners were arrested on drug related charges (Arrestees' #3 & #4). This incident is still under investigation.
