The complainant called the number listed and spoke to a male claiming the computer had a virus. The male claimed the complainant had accessed child pornography and would be arrested. He then spoke to a male claiming to be with a fraud department and told the complainant to remove money out of his account and make two Bitcoin deposits, which the complainant did. The complainant spoke to two additional males claiming to be with Microsoft and he provided his computer IP address to them. The complainant's wife also received several phone calls from the male claiming to be from the bank fraud department.
