Sheriff Greg Champagne reports deputies responded to the report of a carjacking in the 16000 block of River Road in Taft. Two females reported a male subject, armed with a firearm, approached the vehicle they were seated in. The male allegedly told the female that was seated in the driver's seat to take him to Hahnville, while pressing the firearm to her head. That female exited the vehicle and the male got in. He drove to a convenience store in Hahnville while the second female was seated in the rear of the vehicle. The male fled from the vehicle at the convenience store and the second female was able to drive to safety. Video evidence showed the male entering another vehicle that deputies were familiar with. That vehicle was located a short time later with the male, later identified as Pierce, standing nearby. Pierce was arrested and charged accordingly.
