**Incident Briefs:**

<b>Incident:</b>	Burglary of a vehicle (4 Counts) and Simple criminal damage to property (2 counts)
<b>Location:</b>	13000 block of Highway 90 in Boutte, LA
<b>Date:</b>	January 20, 2023
<b>Incident Number:</b>	2300393
<b>Sheriff Greg Champagne reports the complainant advised four vehicles were burglarized and two vehicles had windows shattered.</b>	

<b>Incident:</b>	Aggravated assault with a firearm, Aggravated battery, Aggravated criminal damage to property
<b>Location:</b>	Interstate 310 Northbound in St. Rose, LA
<b>Date:</b>	January 21, 2023

<b>Sheriff Greg Champagne reports the complainant advised he was involved in a minor "fender bender" in a neighboring parish that lead to a verbal altercation. He left the scene, and while traveling on Interstate 310, a vehicle pulled beside him on the roadway and he heard a loud "boom." The complainant and a teenage passenger received minor injuries that were treated at a local area hospital prior to notifying the Sheriff's Office.</b>	

<b>Incident:</b>	Armed Robbery
<b>Location:</b>	16000 block of River Road in Taft
<b>Date:</b>	January 21, 2023

<b>Sheriff Greg Champagne reports two females advised a male, armed with a firearm, approached the vehicle they were seated in. The male allegedly told the female that was seated in the driver's seat to take him to Hahnville, while pressing the firearm to her head. That female exited the vehicle and the male got in. He drove to a convenience store in Hahnville while the second female was seated in the rear of the vehicle. The male fled from the vehicle at the convenience store and the second female was able to drive to safety. Video evidence showed the male entering another vehicle that deputies were familiar with. That vehicle was located a short time later with the male standing nearby. The male was arrested.</b>

<b>Sheriff Greg Champagne reports a vehicle that was reported stolen from a nearby parish was found burned. The bottom of the overpass was charred, and the concrete and metal structure of the bridge was damaged.</b>
