<b>Sheriff Greg Champagne reports the complainant advised he observed four to five subjects in a neighbor's driveway. The complainant yelled at the subjects, and they left the area in a red pickup. Responding deputies were unable to locate the vehicle or subjects. This incident is related to incident number 2301602.</b>

<b>Sheriff Greg Champagne reports the complainant was alerted by her home camera system of movement in her driveway. The video showed four subjects wearing hooded jackets and gloves walking on the street, followed by a pickup. The pickup that was following the subjects was reported stolen from St. Rose on March 19, 2023. It was recovered by a nearby parish with two subjects in their custody.</b>
