## **ARREST OF WANTED SUBJECT LEADS TO THE SEIZURE OF FIREARMS AND ILLICIT NARCOTICS**

On November 26, 2024, deputies observed known wanted subject Dakyri Bradley while patrolling a Hahnville neighborhood. Deputies made contact with Bradley and took him into custody. Also located at the residence and ultimately arrested was Jaheim Strickland. Deputies contacted the Special Investigations Division, and detectives obtained a search warrant for the residence. During the execution of the search warrant, the following items were recovered:

- A 9mm handgun with an extended magazine and ammunition
- A 300 Blackout AR pistol and ammunition
- 38 doses of Tapentadol Hydrochloride tablets
- Amount of Tramadol tablets
- Amount of Marijuana
- AR15 5.56 magazine
- AR15 7.62 magazine
- US Currency
- Digital Scale

Dakyri Bradley was arrested and charged with:

- Illegal carrying of a weapon in the presence of a CDS
- Possession of marijuana
- Possession with intent to distribute Tapentadol Hydrochloride tablets
- Possession of Tramadol
- Possession or distribution of drug paraphernalia
- Transactions involving proceeds from CDS activity
- Attachment arrest

Dakyri Bradley has a lengthy criminal record. He's been arrested relative to Unauthorized Use of a Motor Vehicle, Disturbing the Peace, Possession of Marijuana, Possession of Adderall, Resisting an Officer, Illegal Carrying of a Weapon in the Presence of a Controlled Dangerous Substance, Illegal Possession of a Stolen Firearm, and Theft.

Jaheim Strickland was arrested and charged with:

- Harboring a fugitive
- Possession of a firearm/carrying concealed weapon by a convicted felon

Jaheim Strickland has a criminal record with the St. Charles Parish Sheriff's Office and has been arrested relative to the Possession or Distribution of Drug Paraphernalia, Possession with intent to distribute marijuana, and Hit and Run.
