At one point, Adams told the female he was going to get his gun and threatened to harm her. Deputies located Adams near his residence and took him into custody. While speaking to Adams deputies observed a dog in Adams' vehicle that had obvious injuries. The dog was taken to the animal shelter and assessed. A representative for Animal Control advised that the dog had been struck by a vehicle and not treated for its injuries. Adams was transported to the NCCC and booked accordingly.
