## News Release

October 15, 2010

### Home Invasion

In the early morning hours of October 14<sup>th</sup>, 2010, police were dispatched to a home invasion at 681 Magnolia Ridge Road in Boutte, Louisiana.

The victim, who resides at 681 Magnolia Ridge, Stated that on October 13, 2010, he returned home with a black female known only to him as %chocolate+. He advised that later that evening he brought the female to a gas station on Williams Blvd. In Kenner, where he dropped the female off to her friends, who were two W/M subjects driving a maroon Chevy Impala with Texas plates. The victim returned home and went to sleep, shortly after, he was awoken by four unknown white males, who kicked in his door and then pointed a shotgun in his face. The gunman demanded money and one of the subjects repeatedly stated, %kill him+; at which time the victim was struck in the face with the shotgun.

The victim then began fighting with the individuals and was able to gain control of the gun. Three of the four subjects then fled the scene; however the victim was able to physically detain the fourth suspect. The victim subdued the fourth suspect and notified the Sheriff's Office where he was able to provide 911 Operators with the vehicle's description. Deputies conducted a traffic stop on the vehicle at I-310 in St. Rose, Louisiana. The vehicle pulled over for a brief moment then led deputies on a pursuit through Kenner and Jefferson Parish. St. Charles Parish Deputies along with the Louisiana State Police apprehended the subjects in the PETSMART parking lot on Veterans Blvd. in Metairie, Louisiana.

The victim suffered minor abrasions during the incident.

The suspects: a **B/F Juvenile** (charged with: Armed Robbery, Principle to Att. 1<sup>st</sup> Degree Murder, Prostitution by Massage), **Steven Fallon W/M**, 11-2-88 from Montegut (charged with: Armed Robbery, Principle to Att. 1<sup>st</sup> Degree Murder, Felony Carrying Illegal Weapon, Cont. to the Delinquency of a Juvenile, SCSO Attachment), **Angela Wheat W/F**, 11-17-83 from Independence (charged with: Armed Robbery, Principle to Att. 1<sup>st</sup> Degree Murder), **Gabriel Kleinpeter W/M**, 5-10-88 from Independence (charged with: Armed Robbery, Principle to Att. 1<sup>st</sup> Degree Murder, Felony Carrying Illegal Weapon), **Dustin Haney W/M**, 1-17-90 from Monroe (charged with: Armed Robbery, Principle to Att. 1<sup>st</sup> Degree Murder, Aggravated Flight from Officer, Felony Carrying illegal weapon), and **Pedro Witham W/M**, 5-30-88 from Metairie (charged with: Armed Robbery, Principle to Att. 1<sup>st</sup> Degree Murder) Witham was detained by the victim until deputies arrived and then transported to St. Charles Parish Hospital for his injuries.

All subjects are being held without bond.
