Sheriff Greg Champagne reports shortly after 7:00 p.m., deputies of the St. Charles Parish Sheriff's Office responded to an armed robbery that took place at the Subway restaurant located at 112 St. Rose Avenue in St. Rose. During the investigation it was determined that a black male, approximately 5'10" tall with a slim build entered the Subway restaurant clad in a grey sweatshirt with pink hood and blue jeans. The subject produced a handgun and ordered the employee to relinquish money from the cash register. After receiving the money, the subject fled the scene on foot.
