Sheriff Greg Champagne reports a deputy recognized Amber Scott from a "B.O.L.O." (Be On The Lookout) sent by Lafourche Parish Sheriff's Office. The B.O.L.O. was in relation to Amber Scott being wanted for two counts of Armed Robbery and one count of Attempted Murder. Deputies approached Scott who initially identified herself using a fake name. Derrick Usey was with Scott and also lied to deputies about Scott's name. Both subjects were detained, and a Louisiana Identification Card was found, identifying the female as Amber Scott. It was learned that Usey had knowledge of Scott's criminal investigation, and knowingly lied to deputies about Scott's name in an attempt to keep her from being arrested.
