<p>Sheriff Greg Champagne reports that the five above mentioned subjects were arrested during an ongoing narcotics investigation starting in March of 2018.</p> <p>On June 25, 2018, narcotics detectives conducted a stop on a vehicle operated by Brian Koontz with intentions of arresting him for a warrant issued in relation to operating/creating a clandestine lab. During the stop, both Brian Koontz and a second passenger, Melissa Adams, were placed under arrest for possession of drug paraphernalia and possession of methamphetamine.</p> <p>Detectives then executed a search warrant on the residence of Brian Koontz and Melissa Adams. During the search, detectives located heroin, drug paraphernalia, methamphetamine, diazepam pills, steroids, and two firearms. The other occupants of the residence, Amy Bush, Heather Stumpf, and Troy Rome, were arrested accordingly.</p>
