<b>Incident:</b>	Theft from a vehicle

<b>Sheriff Greg Champagne reports the complainant advised she received a phone call from a male claiming to work for the Federal Trade Commission and is investigating identity theft. He claimed someone was attempting to open accounts using her identity and that access to funds in her account may be limited. He requested her to purchase gift cards and give him the card numbers. The incident was found to be a scam. The subject called the complainant again claiming to be a deputy with the Sheriff's Office.</b>
